

Part-Time Virtual Education Partnership Agreement

The following school districts agree to enter into a partnership to provide virtual education options for students in the district of full-time enrollment as outlined herein for the 2020-2021 school year.

Service Providing District: School District of Waukesha

District of Full-Time Enrollment: _____

The School District of Waukesha agrees to provide the following services to the district of full-time enrollment at a rate of \$285 per course per semester per student (maximum of 2 courses per semester) where available seats exist in courses. Students will be added to courses on a first-come-first-served basis.

- ✦ Virtual instruction, feedback, and assessment provided by Wisconsin-certified teachers who are licensed in the content area according to DPI guidelines for NCLB implementation
- ✦ Student access to the learning management system and email account
- ✦ Observer access to the learning management system
- ✦ Student access to teachers via email, phone, and/or the online lecture environment
- ✦ Orientation materials and training for the student and observers
- ✦ Progress updates provided to parent/guardian and monitor at school of full-time enrollment
- ✦ End of course grade report
- ✦ Transcript upon request

The district of full-time enrollment agrees to provide the following information and services as a member of this partnership.

- ✦ Student and parent/guardian contact and demographic information essential for a SIS record
- ✦ Name, title, phone number, and email address of a key contact person at the school of full-time enrollment who will monitor student progress
- ✦ Monitoring of student progress through the provided observer accounts
- ✦ Any IEP required special education services and support
- ✦ Verification that each student has adequate Internet and computer access at their home or at a school in their district of full-time enrollment

Payment shall be made within 30 days of invoicing which will occur after October 1 for 1st semester classes and after March 1 for 2nd semester classes. After the semester start date, a \$50 fee will be assessed for each course that a student withdraws from. No refund will be made if the student withdraws after the invoice dates or does not successfully complete the course(s).
